MINUTES OF THE 33rd ANNUAL GENERAL BODY MEETING OF THE KARNATAKA GOAN ASSOCIATION (REGD.) BANGALORE

HELD ON SUNDAY, 3rd JULY 2022 AT CATHOLIC CLUB, MUSEUM ROAD, BANGALORE

The President, Adele Britto called the 32nd Annual General Body Meeting of the Karnataka Goan Association to order.

The Opening Prayer was said by Mr. Alfie Santamaria for all the members of the KGA, for the members who had passed away, and for the growth and development of the KGA.

1. To read the Notice convening the Meeting: The Notice was read by the President Adele Britto. It was taken as read by all. Proposed by Gerald Pereira and Seconded by Jonathan Smith.

2. PRESIDENTS ADDRESS 2022:

The year 2021, started out comparatively better than 2020 with regard to the pandemic and the Managing Committee optimistically, put many plans in the pipeline, like the KGA Picnic cum Sao Joao Celebration & the Youth Overnite Trip (which we managed to have in Sept 21) but with the 2nd wave spreading like wildfire in April/May 2021, we had to shelve many plans, stay home and once again look at Online Events for the KGA. The AGM which was fixed for 30th June 2021, had to be cancelled and the uncertainity continued, until 10th Oct 21, when we were able to conduct the AGM. There were no takers for the principal roles on the Managing Committee despite our personal efforts to convince many members and some of the Committee Members decided not to continue for the remaining term. We bid goodbye to Denzil Pereira, Romario D'Monte and Peter Coutinho who had been largely instrumental in the KGA activities success

The MC of 2021-22, saw new faces, as well as some old & experienced members. The feeling was, to watch the scenario, plan the Events and other work pertaining to the KGA, keeping the whole situation in mind. It was clear though, that planning for Festa Do Carnaval 2022, would not be possible because of the uncertain situation. That, was a bit of a dampener but nevertheless, we decided to go ahead with whatever was possible. The 1st Event for the new Committee was the **Holy Rosary & Ladainha** held on the last day of Oct 21. That Event itself was fraught with uncertainity because

of the death of a young filmstar, ensuing riots & processions. With the Blessings of Our Lady, we did go ahead and were pleasantly surprised to see the number of members gathered together for the Event. We had slight Showers of Blessing but thankfully the overcast sky did not turn into a heavy downpour.

The next Event was **the St Francis Xavier Konkani Feast Mass & Christmas** dinner on the 3rd Dec 21. A lot of preparation went into the Event. The Konkani Choir with Aldrin at the helm, was one of the best we've heard in a long time and the kids' choir, was heartwarming & beautiful. Sumptuous Goan snacks like choriz pao, kaddio boddios, doce and beef croquettes were washed down with Feni brought from Goa, SantaClaus with his bag of goodies and gifts for the Kids' Christmas Tree, the Christmas pageant by the kids, a lip smacking dinner & music from Fabian & Mario Esteves, kept everyone on the Dance Floor. The EXCELLENCE AWARDS were distributed to 7 of our talented & meritorious youngsters by our Guest of Honour, our very own Dr Norman Guido. This Event celebrating the Goencho Saib & the bringing in of Christmas, will continue to be KGA's signature Event.

Around Christmas time, the KGA has a lovely tradition of visiting the homes of the Evergreens who are home bound and unwell, for Carol singing & taking along a box of Christmas goodies. Since the corona pandemic hadn't really abated, we did not want to put our seniors at risk by visiting their homes. However, **Christmas Hampers** were sent to 30 of our Evergreens with a personalized Christmas Card & large Hampers with groceries & other necessities were given by the EWP to 7 members with greater need. Their happy faces are on the cover of the Annual Report.

The Book Reading Event in the 2nd week of May 22 was unique, in that, both the Author & Moderator are members of the KGA. Marianne deNazareth's captivating book 'Some Bark..Some Bite' Reading was held at Catholic Club. Aiona Misquita was the moderator & she did an excellent job. The interaction was remarkable and definitely kept the audience glued to their seats for the entire duration.

The 'Sun, Sand & Surf ' theme was the Event for our Evergreens in May 22. The Skylounge, Catholic Club was converted into a seaside resort with coconut fronds, fishing nets, surfboards, shells, boats, a bit of sea sand thrown in as well & it transported one to exotic Goa. The Ramp walk to Story telling to dancing and scrumptious food & beverage, the Evergreens had a rollicking time. The prizes of Lunch/Dinner for 2 at Bangalore's 5 Star Hotels was an added incentive. To wind it up, each Evergreen was presented with an awesome Mario Miranda pic Mug to carry home memories of a wonderful day.

As this Report goes to print, the **Youth Retro -tec Event** is in the pipeline and preparations for it are on.

This year 2021-22, the MC did manage to keep the Calendar of Events going to a limited extent, keeping an eye on the prevailing situation, in addition to handling all issues pertaining to the KGA successfully. The water logging of the CSM area during the incessant rains in Oct/Nov 21, saw the room which is stacked with KGA files, documents, Carnival costumes & props flooded with almost 2 feet of stagnant & waste water. A massive cleaning and sorting activity by the hardworking MC and Asset Management Committee members was undertaken to save the existing costumes & props. Fortunately, the paper documents were in the Godrej cupboards and were safe. The heavy rains in June 22, has seen a recurring problem as the entire area is water logged again. The tenant is facing tremendous hardship with the water tank rising up & tipping at an angle due to the flooding. Temporary measures have been put in place. Once the rains subside, a solution regarding the flooding of the premises should be worked out.

The Education & Welfare Panel were very responsive to members in need. A Total amount of Rs 2,32,518/ was disbursed during the year. Rs 1,29,762/ as Education Grants & Rs 1,02,756/ as Welfare disbursements. The Budget to be utilized was Rs 3 Lakhs. Thanks to Col Mario Dsouza, Oscar Menezes, Noel DeNazareth, Alfie Santamaria, Daphne Smith, Debbie Rodricks, Olinda Timms, Aiona Misquita & Brian D'Lima. Oscar Menezes & Olinda Timms will be stepping out of the EWP. We express our thanks to both of them for their commitment.

The Asset Management Committee had a busy time with the flood situation & cleaning operation & the recurring problem of water logging at CSM. The AMC members & the MC members did a marathon cleaning, discarding & sorting exercise at the CSM room, to salvage what was possible of the KGA costumes & props which were inundated after water entered the room to a height of nearly 2 feet because of the water logging in the entire area. The necessary amount was paid for the Cauvery water connection at the request of the CSM Residents Association. All Fixed Deposits were renewed. Zoom Pro availed of during the pandemic for online activities was disabled. Grateful thanks to Brian D'Lima, Joey Santiago & Lawrence Pereira.

The Advisory Committee met once online with the principal Managing Committee members. The MC sought their advice on whether the KGA could tie up with the Catholic Club for a Joint Carnival, among other things, as we were not able to organize our traditional Event of Festa do Carnaval in 2022 due to various circumstances. The

Advisory were not in favour of doing so, which was accepted by the MC. We thank Francisco Saldanha, Perry Goes & Arun D'Silva for their valuable advice & support.

Grateful thanks to Francisco Saldanha for his support in designing the Annual Report & maintaining the KGA website.

As at the end of March 2022, the KGA had a healthy & robust **corpus** of Rs 95,75,466/. However, a point to be remembered here, is that for 2 consecutive years 2021 & 2022, the Carnival which is our main fund raiser could not be conducted. For the KGA to grow & be sustainable, a strong financial base is vital.

The MC has incorporated a Resolution with regard to the upcoming **Golden Jubilee** of the KGA (2023-24) which will be taken up for discussion during the proceedings. With regard to the decision at the AGM 2021, letters have been sent to the existing Associate Members to update their Membership with the revised Membership Fee of Rs 10,000/. An appeal to all Life Members to update their Membership to either Donor or Patron to augment funds further.

My appreciation & thanks go out to the MC members of Wilma Pereira, Elaine D'Souza, Cyrus D'lima, Paola Ravishankar, Lizanne Arya, Bosco Andrade, Deborah D'Souza, Joanne Louzado & Zuriel Coutinho for their excellent support & effort. My apologies if I have been a little short with any of you, especially when work for the KGA had to be done, please put it down to my desire to keep things going at the level that was expected of us. My warmest gratitude & thanks to all of you.

It will be absolutely remiss of me, if I miss mentioning my hubby, Gilbert Britto who has kept up his word from 2019 to date, to give me the support & help I needed as President. I would not have been able to do much if he didn't give me unconditional support. Thanks Gilly. Keep the KGA flag flying high & triumphant always!

- **3.** Consideration and Adoption of the Annual Report: No queries were received or clarifications sought, hence the Annual Report was taken as read and passed. Proposed by Noel Pereira and Seconded by Oscar Menezes.
- **4.** To reappoint the Internal & External Auditors for the year 2022-23: The President Adele Britto on behalf of the MC proposed that Ryan D'Souza continue for the next term (2022-23) as the Internal Auditor as he had done a meticulous & excellent job. Ryan D'Souza accepted the proposal. She also proposed Mr Ravi Lobo

& Co to continue as the External Auditor for the next financial year 2022-23 which was unanimously accepted by the General Body.

5. To consider, and if found fit, to adopt the proposals with or without amendment:

In the AGM 2022, the General Body discussed the allocation of funds from the upgradation of Life to Donor/Patron and New Membership to be transferred to the Golden Jubilee Fund. There were different views on this:

The MC proposed, in addition to the above, an appeal can be sent out to Members and Well Wishers to contribute generously to the Golden Jubilee Fund. The following discussion took place in this connection:

Brian expressed that this was a proposal from the Managing Committee and if the General Body passes it, then the Golden Jubilee Fund will be created & augmented with the upgradation amounts from the Membership as also New Members.

Francisco felt that If it was not going to be used for the Golden Jubilee then why would we need to have this fund? What is the purpose of transferring money from one Fund to another? His opinion was that it would add more work for everyone concerned.

lan was of the view that it may not be a good practice as future committees shouldn't be transferring this amount. He expressed concern about the sustainability of the KGA and that is what matters. The amounts in the fixed deposits help us in the long run. He was not in agreement to have this Golden Jubilee Fund just for the celebrations. He wasn't in favour of this, as a hefty amount would be used only for the Golden Jubilee year. He sought further explanation from Brian to get more clarity

Brian said that this discussion was that the amount was not to be used for the Golden Jubilee celebrations but will be put in a Golden Jubilee Fund, specific use will be decided by the Managing Committee once it is set up.

Francisco was of the opinion that if it was not going to be used for the Golden Jubilee, then what was the need to have this fund. Why should we transfer money from one account to another? In such a situation, why do we need to call it by another name? Wasn't it going to add more work for everyone concerned? He also added that since we do not know what we are going to do for the Golden Jubilee Year, why do we need to have a specific Fund since the KGA has a hefty corpus. He also wanted to know that when money comes in to the KGA coffers, does it go into a Fund?

Brian said that the interest from each fund goes into various funds of the KGA and it has to be used for that particular purpose, it cannot be used for anything else and only the balance amount is available to the Managing Committee for use. If the KGA doesn't have a corpus to spend then it will not give the future Managing Committees to decide on something new in the future. The corpus carries on like before, amounts from new memberships will go into this Fund. There's not diverting of funds, he opined.

Arun was of the opinion, that the information gathered from Brian, was that the KGA has a lot of money but we cannot use it due to certain protocols. We shouldn't be creating more Funds if we cannot use it was his opinion. To which Brian replied that we have the Evergreens & Children's events and to meet the expense we may have to use funds in the Welfare Fund which is not right. We need a special fund for the activities of the KGA. Arun suggested that if we could release those funds which would help the Committee. Perhaps, a Committee could be formed, to rework the finances of the KGA. Ian felt that if money and usage of the money is an issue then say 50% of the amount to be transferred to the Golden Jubilee Fund. The Committee collecting that differential amount has that amount to spend.

Adele said the Golden Jubilee is from 2023-24, the incoming committee should look into the what they plan to do for the next year and the next year's committee is the one which will have to utilise those funds. It was some kind of the strategy now, to prepare for the future. Hence the utilisation was for future managing committees not this present committee. Brian pointed out that KGA rules state that all money from memberships have to be capitalised, instead of putting it in the capital or Reserve fund we are proposing to put it into a Golden Jubilee Fund. He expressed surprise at the reluctance, since it was just that the amount is going into another account in the balance sheet. Adele said that with Aiona's permission, she could state now that Perry is not in Kingfisher anymore, that sponsorship which he used to use his good offices to get for the KGA, looks very doubtful.

Adele said that with our FD's are not earning much. Bank Interest Rates are at an all time low. In the present circumstances, unless KGA retains its brand, it will be difficult to get sponsors for a KGA Event. To get advertisements to create that Fund may be difficult in the present market conditions.

lan felt that we should think out of the box. See how we can build on the spirit of KGA. He also felt that there were too many conditions and restrictions in the committee. He

said that you cannot expect the newly elected committee to be tied up with all that is happening. He was of the opinion that some of our Past Seniors are unnecessarily interfering with the working of the Association. In his opinion there wasn't any need to have a super Advisory Committee. The Committee is a creature of the General Body. He felt that we should think big like why not have a Joint venture with Catholic Club for the Carnival

Francisco said what Catholic Club calls a Carnival, there's nothing goan in it. Some of the seniors feel that our goan culture is lost having a joint venture with CC. He stated that we bring back the spirit of KGA, get back the bonding fellowship that's what we should be bothered about. When KGA had joint events with Catholic Club in the past, certain things have happened between CC and KGA. Mango showers was an example. It became a CC show. In the beginning, we used to have dances and promote our culture. The way CC had the Carnival was disastrous. It definitely was not the Carnival we know. CC shows are only for dancing and not to showcase any culture. Just advice to the committee is not given but it is to discuss and how to move forward. Let's all work together to bring the spirit of KGA back. Arun felt if we had a joint venture with CC for the Carnival, having had the experience of it during his term as President, what the KGA gets is peanuts.

Adele responded to the discussion that the MC valued the advice of the Advisory Committee and after evaluating the pros & cons the MC took a decision not to tie up with CC for the Carnival.

Adele requested Brian who comes with so much experience to summarise this discussion. He proposed that we keep this Golden Jubilee Fund for 2 years, use it for the celebrations and capitalise on the balance. Closure of the Golden Jubilee Fund in 2024, was passed at the General Body.

An outline of plans can be discussed to make the Golden Jubilee Year 2023-24 a memorable year in the annals of the KGA: Everyone felt it is better to leave it to the new Managing Committee to discuss how they want to go about it.

The Panel formally met 3 times during the year besides multiple inter actions on phone/WhatsApp as and when required.

The following Assistance was provided during the year:

Education:

1. Rs. 50,000/ was provided towards education of one student.

Welfare:

- 1. Rs. 1,13,000/ was spent towards expenses of 3 members who have been facing health & financial difficulties.
- 2. Large hampers of necessities & groceries were given to 6 members with greater need at a cost of Rs. 8.459

Summary: A sum of Rs. 1,71,459/- was disbursed during the year out of which Rs. 50,000/- was towards Education and the balance of Rs 1,21,459/- towards Welfare activities. We express our appreciation for the cooperation received from the Managing Committee in disbursal of funds to the members in need. In addition, several members of the panel visited and interacted with older members of the KGA as well as those not in good health.

Recommendation: It is recommended that volunteer youth join the EWP members during their visits to older members who we feel would be very happy to meet them.
